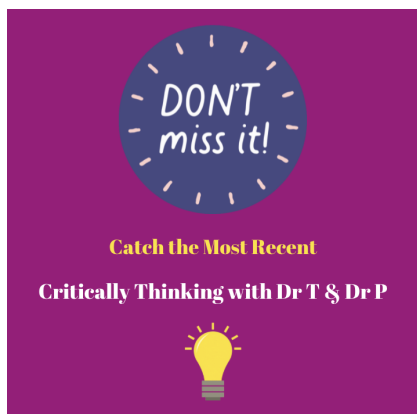

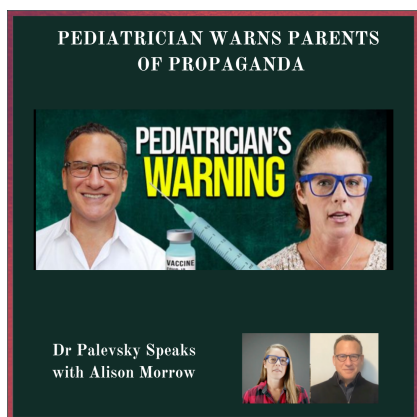

### What the WHO...? | Stand for Health Freedom

At an unexpected meeting in November 2021, the World Health Organization Assembly met and voted to create an Intergovernmental Negotiating Body to strengthen the authority of WHO governance of global health responses. The group wants to expand and strengthen the powers of the WHO by creating a treaty or agreement where the 194 nations and territories that are members of WHO would be legally bound to global pandemic emergency protocols.

We don't yet know what the agreement entails entirely because it's not yet written. But we can make an educated guess based on what the WHO has been up to over the years, including the company it keeps.

Stand for Health Freedom is opposed to any global agreement that would threaten US sovereignty with respect to health freedom.

## Liability-Free Products Put Our Children at Risk

**In Tuesday night's State of the Union Address, President Biden claimed gun manufacturers are the only industry in America that can't be sued and called on Congress to repeal their liability shield.**

This is completely wrong.

The vaccine industry has been avoiding the inside of a court room since the National Childhood Vaccine Injury Act of 1986 went into effect. When a child is injured or killed by a vaccine their parents cannot sue the manufacturer or the person who administered it.

Even though gun manufacturers are shielded from most lawsuits against them for use of their products, there are 6 exceptions in the law protecting them, so they're not completely immune from suit.

It's 100% unacceptable for our president to spread this kind of misinformation while trying to "vaccinate America." Understanding risk includes knowing what your options are if something goes wrong and is a crucial part of informed consent.

Because of the 1986 Act, there's virtually no way for a vaccine manufacturer to be held accountable for creating and selling a product that's "unavoidably unsafe" according to the SCOTUS.

It's a horrific failure of our lawmakers to leave American children so vulnerable and essentially abandoned when they're injured or killed by a product that's meant to protect them and the public. It's time our elected officials do something about it and start shielding our children from harm instead of shielding public health profiteers from responsibility.

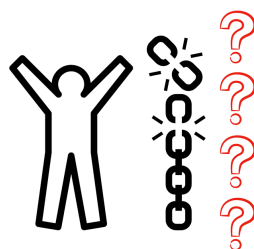

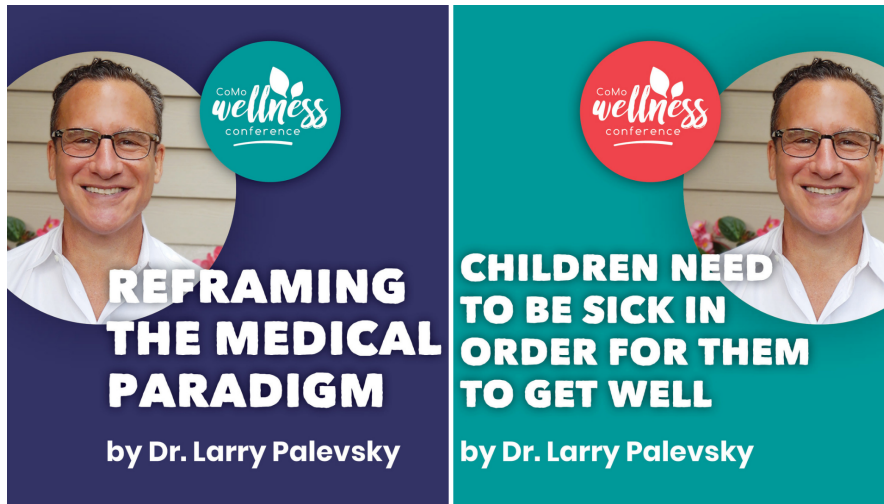
