New York Take Action: New Bill S7573 Protects Medical Exemptions to Vaccine Mandates

State Senator Monica Martinez (D-Suffolk County) has introduced a new bill, S7573, that protects the medical exemption from vaccine mandates, and restores it to the clear intention of the letter of the law: the medical judgment of the child's physician shall prevail, and his or her decision may not be overridden by school or public health authorities. This bill would take school administrators and the NYS and NYC Departments of Health out of the decision-making process, and put it wholly under the control of the attending physician. This bill will put an end to the strong arm tactics of Governor Cuomo's Department of Health, and Mayor de Blasio's Department of Health and Mental Hygiene, whose main goal is to maximize sales of vaccines, regardless of the consequences to the health of those who were forced receive the shots.

New York Public Health Law Section 2164, Paragraph 8 is explicit, "If any physician licensed to practice medicine in this state certifies that such immunization may be detrimental to a child's health, the requirements of this section shall be inapplicable until such immunization is found no longer to be detrimental to the child's health." But over the years the NYC and NYS Departments of Health progressively encroached on the authority of the doctors actually treating a child, and allowed school personnel to routinely override the medical decisions of physicians, or intimidated doctors and schools into not writing or accepting legitimate medical exemptions. The Departments of Health has create a bizarre situation where school

employees who do not have medical licenses are allowed to override the medical decisions of physicians, allowing them to practice medicine without a license, which can be a felony in NY.

Thousands, perhaps tens of thousands of parents, in New York have had the experience of a physician telling them that their child should not receive some or all vaccinations for medical reasons, only to be told by the physician to go get a religious exemption because they were either afraid of retaliation from the Departments of Health or afraid that the medical exemption would be denied. The result is that getting a medical exemption in New York became very difficult and nearly impossible in New York City. Only 1/5 of 1% of New York State students have medical exemptions, and in New York City the rate was even lower at 1/10 of 1%. We obtained through a Freedom of Information request records that showed between 2013 and 2018 New York City denied 56% of all medical exemptions.

New York's legislators were well aware of this situation last spring when they voted to repeal the religious exemption. We thoroughly documented the problem and spent hundreds of hours explaining the situation. They knew that thousands of families would be faced with the choice of either pulling their children out of school, many of them with special needs, or subjecting their children to vaccines that their physician, sometimes multiple physicians, had told them could do lasting injury to their child. But they voted for the repeal anyway.

In August the Governor Cuomo made the situation much worse with new NYS Department of Health regulations that only allow a medical exemption in instances where a child has already had a documented near death anaphylactic reaction to a previous vaccine.

Advocates of the repeal of the religious exemption made a great deal of noise about the need to protect immune-compromised people, at the very same time that they were making it nearly impossible for immune-compromised people to be protected. This bill will restore a measure of sanity to New York's insane vaccination policy. It does not create a policy based on informed consent, which is the only acceptable policy in any country that claims to be a democracy that respects individual rights, but it is an important step in the right direction and will help get thousands of children back in school.

The bill does not have a sponsor in the Assembly yet, but we will hope that will be forthcoming shortly.

New York Take Action: New Study Shows There is No Evidence That Merck's Gardasil Prevents Cervical Cancer

A new study published last week in the prestigious Journal of the Royal Society of Medicine shows that in the studies published so far there is insufficient evidence to claim that either of the two human papilloma virus vaccines, Merck's Gardasil and Glaxo's Cerverix, have been shown to prevent cervical cancer, and many of the studies were designed in a way that could not answer that question.

Despite the lack of evidence that these products even work, the vaccine industry's allies in the New York legislature are hard at work trying to force our children to get HPV vaccines, with our consent as parents or not. Right now there is a bill in the New York legislature S298b(Hoylman-D)/A2912a(Paulin-D) that would force all children in the state to get Merck's Gardasil, the only HPV vaccine licensed in the US, or lose the right to attend school. And there are two bills S3899b (Krueger-D)/A973 (Paulin-D) and SS4244(Krueger-D)/A6564 (Fahy-D) that would eliminate parents' right to know what vaccines and drugs are given to our children, primarily to help Merck sell more Gardasil, which is the most expensive vaccine currently sold

in the US, and the most heavily marketed vaccine not currently required to go to school in the overwhelming majority of States.

"We conducted a critical appraisal of published Phase 2 and 3 efficacy trials in relation to the prevention of cervical cancer in women. Our analysis shows the trials themselves generated significant uncertainties undermining claims of efficacy in these data. There were 12 randomised control trials (RCTs) of Cervarix and Gardasil. The trial populations did not reflect vaccination target groups due to differences in age and restrictive trial inclusion criteria. The use of composite and distant surrogate outcomes makes it impossible to determine effects on clinically significant outcomes. It is still uncertain whether human papillomavirus (HPV) vaccination prevents cervical cancer as trials were not designed to detect this outcome, which takes decades to develop."

If the lack of evidence of efficacy wasn't enough, Merck's Gardasil has a terrible safety record, and Merck is a serial felon with an established record of covering up injuries and deaths caused by their products and lying to regulatory agencies.

Gardasil has a terrible safety record. According to the federal Vaccine Adverse Event Reporting System as of 7/14/2019 there have been 62687 reported adverse incidents with HPV vaccines, including 510 deaths, 15,413 emergency room visits, 6,309 hospitalizations, and 3031 permanent disabilities. According a federal Department of Health and Human Services study fewer than 1% of all vaccine adverse events are reported. The safety record for HPV vaccines is so troubling that Japan ended their recommendation of HPV vaccination for Japanese girls in 2014.

Since 2000 Merck has paid more than \$10 billion in the US in penalties, fines, and settlements for a wide range of criminal activities, including damages related to at least 60,000 deaths caused by Merck's Vioxx product, a side effect known to Merck, but kept from the public and regulatory agencies. The time period when Merck was marketing Vioxx, 1999-2004, is the same period that Merck was developing Gardasil, which was licensed after an expedited safety and efficacy review by the FDA in 2006. Merck has also paid \$800 million in fines for submitting false claims to the US government, and \$345 million for bribery and kickbacks.

Merck is charged with submitting fraudulent documents in the Gardasil licensing process. A lawsuit is under way in California, Robi v. Merck, that alleges Merck, the manufacturer of Gardasil, submitted fraudulent safety and efficacy data to the federal government during the licensing process. And there are class actions concerning Gardasil around the world in Israel, Columbia, Denmark, Canada and other countries.

Merck, Gerberding and Fat Rats

SEC filings reveal that Merck's Vaccine Division President Julie Gerberding sold over half her Merck shares in January for \$9.1 Million. That transaction followed a spate of bad news for Merck's flagship Gardasil vaccine.

Last month Cancer Research UK announced an alarming 54% rise in cervical cancer among 24-29 year olds, the first generation to receive the HPV jabs. The following day, the Journal of the Royal Society of Medicine published a withering critique of Gardasil's crooked clinical trials," It is still uncertain whether human papillomavirus (HPV) vaccination prevents cervical cancer as trials were not designed to detect this outcome ". As Gerberding knows, those trials revealed that Gardasil dramatically RAISES (by+46%) the risk of cervical cancer among women previously exposed to HPV. That may explain the cancer explosions in England and other nations with high inoculation rates; Australia, France, Sweeden and Norway.

A 2019 study of Alabama girls found the highest Cervical Cancer rates in the state's most heavily vaccinated counties. With Merck's efficacy pretensions circling the drain, a coalition of leading plaintiffs lawyers are already in discovery in a suit alleging that Merck fraudulently concealed serious illnesses affecting half, and autoimmune diseases affecting 1 of every 37 girls in Gardasil's clinical trials within 6 months of injection.

As CDC Director 2002-2009, Gerberding helped Merck paper over thise efficacy and safety problems. In 2006 she gave Merck the CDC recommendation that made Gardisil a \$3.5 Billion blockbuster. Gerberding did other lucrative favors for Merck; blocking whistleblower Gary Goldman from disclosing that Merck's chicken pox vaccine was causing a deadly shingles epidemic, silencing and punishing Whistleblower Dr William Thompson when he told her CDC bigwigs were destroying data linking Merck's MMR to autism, allowing the company to illegally reformulate

its MMR mumps component. Those courtesies earned her the Merck sinecure and stock options.

Merck Is now fighting existential fraud lawsuits on both the MMR and Gardasil that threaten licensing for those key products. Fat rats are always the first to jump ship.
