Politics and the issues don't stop because we are in lockdown. New York, get on the phone today.

Call the Governor's office and politely let the staffer you know that you oppose Governor Cuomo putting in the state budget any new vaccine mandates, or any provisions that allow minors to get vaccines without parental consent. **Call today, and call everyday, until the budget is passed, which is due April 1.**

Putting controversial items into the State budget is a way for the Governor to get around opposition among the public or legislators. And it is a favorite trick of Cuomo's. That's how he got the very divisive changes to bail laws implemented last year.

One of the causalities of the coronavirus crisis has been any semblance of democratic government in New York. The Governor or New York ordinarily has extraordinary powers compared to the governors of other states. But that power reached a whole new level on March 3 when the legislature passed a bill, with only 15 "No" votes out of 210 legislators, giving sweeping new powers to Governor Andrew Cuomo allowing him to disregard any existing law if he deems that necessary to fight the coronavirus. Cuomo can rule by decree through next year. Cuomo is now the de

facto dictator of New York. The legislature voted itself into being Cuomo's lap dog, so there is no real chance of stopping anything that he puts into the budget.

Cuomo is still bound by some Constitutional constraints and one of those is that he must submit a budget for the legislature to approve. The budget is due by April 1. We have fought hard to stop the slate of bills that take away the shrinking power we have to say what is done to our bodies and our children's bodies. And we must keep fighting, especially now that everyone's attention is diverted.

The most likely moves Cuomo would make are:

- Allowing minors to get drugs and vaccines marketed to prevent sexuallytransmitted infections without parental knowledge or consent. This is where the big money is, probably more than \$1 billion in annual new sales Merck's Gardasil for human papilloma virus, and Truvada, a drug that costs \$24,000 per year and is about as effective as condoms at preventing HPV transmission according to the CDC,
- Adding a flu shot mandate to attend school,
- Adding a mandate for Merck's Gardasil to attend school,
- Allowing children 14 and older to get any vaccine without parental consent, this idea is clearly aimed at undermining homeschooling families, and selling highly marketed vaccines like Gardasil which are not yet mandatory to attend school.

Dr Palevsky's Comments: A test for COVID-19 can only be manufactured based first on the isolation of the COVID-19 virus. Scientists in China had first reportedly isolated the virus in January 2020. Coronavirus tests were developed by foreign countries around the world but, were not accepted by the CDC and the US government. The CDC wanted to develop its own test.

With a legitimate test specifically for COVID-19, we would need to have known the statistics measuring the percentages of false negatives and false negatives, and the capacity to understand if the tests picked up cross-reactivities with any other virus, or any other strain of coronavirus.

No proper preliminary testing was done using this test to understand its sensitivity and specificity. So, what does a positive test really mean?

Dr Palevsky's Comments: As per this article, a 10 month old infant in China is reported to have died of coronavirus. Yet, the infant had a bowel blockage and organ failure, and died four weeks after being hospitalized. Do we know the cause of death? Were there underlying medical conditions, medicines, or procedures that contributed to the baby dying? Is this sensational reporting? Was it coronavirus, or is there more to the story?

A Cook County, Illinois infant is reported to have died of coronavirus. Hidden in a paragraph describing an article in Pediatrics journal about 2100 children in China who had coronavirus, with only 6% of them seriously ill, is the following statement, seemingly out of context with the topic of the 2100 children in China. "A full investigation is underway to determine the cause of death," Dr. Ezike said in a news release.

Separate research published in the journal Pediatrics traced 2,100 infected children in China and noted one death, a 14-year old. The study found less than 6% of children were seriously ill. "A full investigation is underway to determine the cause of death," Dr. Ezike said in a news release. "We must do everything we can to prevent the spread of this deadly virus. If not to protect ourselves, but to protect those around us."

How do you interpret the insertion of Dr. Ezike's statement about the full investigation to determine the cause of death, coming on the heels of the report about the 14 year-old who died in China, among the 2100 children in China who had coronavirus?

Does it sound like the investigation underway to determine the cause of death is related to the 14 year-old who died in China as per the Pediatric journal, or did Dr. Ezike make this statement in relationship to the Cook County infant who reportedly died of coronavirus?

It sounds to me like Dr. Ezike is referencing the Cook County infant who died, and not the 14 year-old in China. It seems she is stating pretty clearly that she does not have sufficient information as to the cause of death of the Cook County infant, so why does the title indicate the baby died of Coronavirus?
