





NY Take Action: Re-Introduced Bill to Protect

Medical Exemptions From Vaccine Mandates to

Attend School

Assemblymember Angelo Santabarbara (D-Rotterdam) has reintroduced his bill to protect the medical exemption from vaccine mandates to attend school, which is now Assembly Bill A1894. State Senator Monica Martinez (D-Suffolk County) the Senate sponsor of the bill in the last session (S7573) lost her seat and there is currently no Senate sponsor. The bill protects the medical exemption from vaccine mandates, and restores it to the clear intention of the letter of the law: the medical judgment of the child's physician shall prevail, and his or her decision may not be overridden by school or public health authorities. This bill would take school administrators and the NYS and NYC Departments of Health out of the decision-making process, and put it wholly under the control of the attending physician. This bill will put an end to the strong arm tactics of Governor Cuomo's Department of Health, and Mayor de Blasio's Department of Health and Mental Hygiene, whose main goal is to maximize sales of vaccines, regardless of the consequences for the health of those who are forced to receive the shots.

New York Public Health Law Section 2164, Paragraph 8 is explicit, "If any physician licensed to practice medicine in this state certifies that such immunization may be detrimental to a child's health, the requirements of this section shall be inapplicable until such

immunization is found no longer to be detrimental to the child's health." But over the years the NYC and NYS Departments of Health progressively encroached on the authority of the doctors actually treating a child, and allowed school personnel to routinely override the medical decisions of physicians, or intimidated doctors and schools into not writing or accepting legitimate medical exemptions. The Departments of Health has created a bizarre situation where school employees who do not have medical licenses can override the medical decisions of physicians, allowing school employees to practice medicine without a license, which can be a felony in NY.

Thousands, perhaps tens of thousands of parents, in New York have had the experience of a physician telling them that their child should not receive some or all vaccinations for medical reasons, only to be told by the physician to go get a religious exemption because they were either afraid of retaliation from the Department of Health or afraid that the medical exemption would be denied.

New York's legislators were well-aware of this situation in 2019 when they voted to repeal the religious exemption. We thoroughly documented the problem and spent hundreds of hours explaining the situation. They knew that thousands of families would be faced with the choice of either pulling their children out of school, many of them with special needs, or subjecting their children to vaccines that their physician, sometimes multiple physicians, had told them could do lasting injury to their child. But they voted for the repeal anyway.

In August of 2019 Governor Cuomo made the situation much worse with new NYS Department of Health regulations that only allow a medical exemption in instances where a child has already had a documented near-death anaphylactic reaction to a previous vaccine. The clear intent of the law was to allow physicians to use their judgment to protect children from potential harm, the regulations now pervert that goal and at best only allow possible protection from a second injury. Advocates of the repeal of the religious exemption made a great deal of noise about the need to protect immune-compromised people, at the very same time


that they were making it nearly impossible for immune-compromised people to be protected.

The result is that getting a medical exemption in New York became extremely difficult, and nearly impossible in New York City. Before the regulations were made more stringent only 1 out of 500 New York State students had medical exemptions, which is less than half the national average, and in New York City the rate was even lower at 1 out of 1000. Between 2013 and 2018 New York City denied 56% of all medical exemptions.

This bill will restore a measure of sanity to New York's insane vaccination policy. It does not create a policy based on informed consent, which is the only acceptable policy in any country that claims to be a democracy that respects individual rights, but it is an important step in the right direction and will help get thousands of children back in school.

ICAN LEGAL UPDATES



ICAN's Letter Exchange With the CDC Director Regarding Requiring Covid-19 Vaccine Injuries to be Reported to VAERS

ICAN, through its attorneys, sent a letter to the Secretary of Health & Human Services requesting that he use his authority under the 1986 Act to require health care providers to report all adverse events following COVID-19 vaccination, except for mild ones, to the CDC's Vaccine Adverse Events Reporting System (VAERS). ICAN's attorneys received a direct response from the Director of the CDC. The CDC Director's lengthy letter goes into great detail about VAERS but fails to answer the one question posed by ICAN. It also makes the incredible claim that COVID-19 vaccines "have been shown to be safe and effective as determined from data by the manufacturers and findings from large clinical trials"! ICAN's attorneys therefore sent another letter to the CDC again asking the Director to answer its simple question.

As addressed in prior ICAN updates, the issue of underreporting to VAERS has been highlighted for over 30 years and is still an ongoing problem. Until these very serious issues are corrected, it is necessary that both manufacturers and health care providers be mandated to report any and all adverse events, aside from mild ones, to VAERS. This is precisely what ICAN, through its attorneys, demanded of Secretary Azar in its December 29, 2020 letter to him.

Despite the fact that it is the Secretary of Health and Human Services who has the authority to require health care providers and vaccine manufacturers to report adverse reactions, events, and contraindications following the receipt of a vaccine to VAERS, the CDC director, Robert Redfield responded to ICAN's letter on January 19, 2021. ICAN had requested that Azar immediately make it mandatory that all adverse events following a COVID-19 vaccination, with the exception of mild events, be reported by vaccine manufacturers and all health care providers to VAERS.

Dr. Redfield (recently replaced by Rochelle Walensky as CDC Director) failed to address ICAN's specific demands and, instead, concluded just weeks after their introduction that the COVID-19 vaccines "have been shown to be safe and effective as determined from data by the manufacturers and findings from large clinical trials." Nothing to worry about, according to Redfield: the manufacturers who are liability-free and stand to profit from worldwide sales of these products have submitted only a few weeks of their own data to show that these vaccines, like every

other vaccine, are "safe and effective." Dr. Redfield goes on to explain the new surveillance program, V-Safe, and confirms that only those events classified as "serious" will be submitted to VAERS. This was the precise problem that ICAN had pointed out and demanded action in response to!

Not surprisingly, ICAN is not reassured by Dr. Redfield's promise that "CDC will continue to be vigilant in monitoring the safety of COVID-19 vaccines and will be transparent in its communications with the public." This has not been the case in the past.

Therefore, ICAN's attorneys wrote to the new CDC Director, Rochelle Walensky, demanding the same actions it originally demanded of Secretary Azar. The letter enclosed the original letter to Secretary Azar, Dr. Redfield's non-response, and a copy of ICAN's letter exchange with HHS regarding overall vaccine safety.

Will the new Director take this issue seriously enough to review this information? Will she address ICAN's justified and serious concerns? Time will tell.

ICAN will continue to hold HHS, FDA, and CDC accountable for vaccine safety.

ICAN will never stop fighting for true informed consent and continues to build its case that the federal government is withholding or obstructing the information needed to give such consent.
